## IMC to Provide Real Time Location System Asset Tracking for VA Rocky Mountain Network

**Dulles, VA, 8 October 2019** – [Innovative Management Concepts, Inc. \(IMC\)](#), an information technology services and solutions provider, has been awarded a three-year task order (TO) for [U.S. Department of Veterans Affairs](#) Real Time Location System Asset Tracking Sustainment for the VA Rocky Mountain Network (VISN 19). The TO, won through the Transformation Twenty-One Total Technology Next Generation (T4NG) acquisition program, began on 16 August 2019 and will continue into 2022.

VISN 19 is located in Glendale, Colo., and was established in March 1996 as one of 21 Veterans Integrated Service Networks (VISNs) in the Veterans Health Administration. VISN 19 functions as the responsible structure for the planning, budgeting, and service delivery in the provision of healthcare to Veterans within our geographic region. VISN 19 spans a geographic area of 540,000 square miles across 10 states and is the largest VISN in terms of geographic area in the 48 contiguous states. VISN 19 serves an area covering the states of Utah, Montana, Wyoming, Colorado, Oklahoma and portions of Idaho, Kansas, Nebraska, Nevada and North Dakota. It is estimated over 1,000,000 Veterans reside within VISN 19's geographic boundaries.

IMC will assist VISN 19 by providing project management, battery management, Centrak maintenance support, Intelligent Insite maintenance support, and server support and administration.
