## IMC Wins Task Order to Provide IT Support to Army National Guard National Capital Region

**Dulles, VA, 12 March 2019** – <u>Innovative Management Concepts, Inc. (IMC)</u>, an information technology (IT) services and solutions provider, is pleased to announce receipt of a task order award to provide IT services to the Army National Guard (ARNG), National Capital Region (NCR), Directorate of Information Management (DOIM) in Arlington, VA. The award was made on 20 November 2018, with an effective start date on 10 December 2018. General Services Administration's (GSA) Federal Systems Integration and Management Center (FEDSIM) made the award on the GSA Veterans Technology Services (VETS) 2 Government Wide Acquisition Contract (GWAC). The VETS 2 GWAC is a vehicle for contracting with Service-Disabled, Veteran-Owned Small Business that is available for use by all federal organizations for IT services. The initial award amount is \$4.8M and the total potential value for the five-year effort, should all options be exercised, is \$130.5M.

IMC will provide the ARNG with support for the operation, maintenance, modernization, expansion, and further evolution of the NCR DOIM and the associated IT services, infrastructure support, and program management services. This task order supports the ARNG NCR DOIM IT infrastructure, its Campus Area Network (CAN), Local Area Networks (LANs), and associated services.

Dr. Robert Might, president, chief executive officer, and founder of IMC, stated that "IMC's NCR DOIM Team is completing the transition process with a planned late-March 2019 implementation. IMC will support the introduction of the Information Technology Infrastructure Library (ITIL) best practices framework as the basis for the IT service management model. We're very pleased and proud to have been selected in this competitive process to provide these critically important services to the Army National Guard."

IMC is teamed with General Dynamics Information Technology (GDIT) and Metova Federal for this effort. GDIT is a long-time IMC partner on similar IT services contracts and task orders and Metova is also a Service-Disabled, Veteran Owned Small Business.
